### *About BOMA Nova Scotia*

BOMA Nova Scotia is the Nova Scotia local of the Building Owners & Managers Association (BOMA). BOMA originated in the United States as an association dedicated to members of the commercial real estate industry, including owners and managers as well as those professionals providing goods and services to the industry. Since its origins in 1907 BOMA has grown and prospered, dedicating itself to establishing best practices and researching real estate topics that would be valuable to commercial real estate managers, operators and suppliers.

BOMA Nova Scotia is one of the eleven federated locals that together form BOMA Canada, which represents over 3,200 members in regional associations across Canada. On behalf of the building owners, managers, developers, facilities managers, asset managers, leasing agents, brokers, and the product and service providers to over 2.1 billion square feet of commercial real estate in Canada, BOMA addresses issues of national concern, and promotes excellence in the industry through information, education advocacy and recognition.

BOMA Nova Scotia's mandate is to provide commercial real estate leadership and support throughout Nova Scotia, and we have established a mission statement to guide us:

***To actively represent our members, through education, networking and lobbying, in matters affecting the ownership, management and operation of commercial properties.***

BOMA offers classroom courses leading to designation programs (administered by our sister organization BOMI). Designations include the Real Property Administrator(RPA®); for property managers, the Facilities Management Administrator (FMA®) for facilities professionals, the Systems Maintenance Administrator (SMA®) for systems supervisors, and the System Maintenance Technician (SMT®) for systems technicians.

- Seminars and presentations on current topics.

BOMA Nova Scotia offers seminars on industry-relevant topics, and holds regular luncheons with speaker presentations.

BOMA Nova Scotia holds a variety of events each year. These include our popular annual Golf Tournament, Speaker Luncheons, member-only free Building Tours, a Holiday Luncheon each December, and a variety of social events.

BOMA's national conference BOMEX takes place each Fall, and brings together BOMA members from across Canada. The event includes educational sessions, keynote speakers, an Awards Gala and a Golf Tournament.

- ***Access to the BOMA BEST environmental certification program***

BOMA BEST (**B**uilding **E**nvironmental **S**tandards) is a national program launched in 2005 by BOMA Canada to address an industry need for realistic standards for energy and environmental performance of existing buildings based on accurate, independently verified information.

The certification is available for five specific asset classes: offices, shopping centres, open air retail plazas, light industrial buildings, and multi-unit residential buildings (MURB).

- ***Advocacy with Government and other legislative and policy makers.***

BOMA Nova Scotia representatives sit on a number of provincial and municipal committees, and our organization releases statements on industry issues as required. BOMA Nova Scotia also contributes articles on industry issues to respected publications.
